

Pursuant to Article 69 of the Law on Games of Chance (Official Gazette of Montenegro No. 52/04, 13/07, 73/10, 40/11) Elektroprivreda Crne Gore AD Nikšić (hereinafter: EPCG), with Head Office in Nikšić, 2 Vuka Karadžića St, Nikšić, The Company's PIB 02002230, hereby passes the following:

**RULES OF THE GAME OF CHANCE
for the prize contest**

«Let the Good Energy Drive You»

I The prize contest called “Let the Good Energy Drive You“ shall be organized in the period from December 1st, 2015 to January 20th, 2016, with the aim of fostering loyalty amongst customers who settle their liabilities for consumed electricity on regular basis.

II It has been envisaged for the prize contest to be comprised in one round:

The public prize draw will be organised in the studio of TVCG on January 19 at 11:00h and it will be broadcast within the morning show of TVCG on January 20, which is broadcast from 06:30h until 11:00h

III Prize fund composes of the following:

- Automobile Ford Mondeo 2.0 TDCi Trend Diesel, 4 doors, in the value of €25,560.00 VAT included.
- 1 5-day arrangement for the travel to Barcelona for two (May 2015). Value of a single arrangement per person amounts to €550.00, VAT included. Total value of the prize amounts to €1,100.00, VAT included.
- 2 arrangements for two persons each, for winter holiday at Vučje (from February 7th – February 15th, 2016). The value of a single arrangement per person amounts to €380.00, VAT included. Total value of the prize amounts to €1,520.00, VAT included.
- 2 iPhones 6
Value of one device amounts to €669.60, VAT included. Total value of the prize amounts to €1,339.20, VAT included.
- 5 vouchers for purchase in Roda markets in the value of €200.00 each.
The value of the prize amounts to €1,000.00, VAT included.

IV Total value of the prize fund amounts to **€ 30,519.20**, VAT included.

V All customers from the category of HOUSEHOLDS who are members of the Golden Team, as well as all customers from the category of HOUSEHOLDS who settle their liabilities by December 31st, i.e. whose debt towards EPCG amounts to 0 on December 31st, shall be entitled to participate in the prize contest.

Members of the Golden Team – all customers who exercise their right to 10% discount on their December electricity bills.

VI. During the prize contest, all bills of the customers from the category of HOUSEHOLDS who have settled all their due debts in accordance with terms stated in Article V, shall be collected in the separate data base, which will be organized by EPCG and the validity of which will be under the responsibility of EPCG. The system of drawing the winners shall be organized by the method of random electronical selection of the collection reference number. After the President of the Committee pushes the button, the collection reference number of the winner, as well as the town in which the collection reference number is located, will be indicated on the screen. The name of the winner shall be published upon announcement of the winners in daily newspapers, in accordance with Article XI.

VII EPCG shall be held harmless against any technical irregularity during the process of prize draw which may be characterised as *force majeure*.

VIII The public prize draw i.e. establishment of prize contest results will be organised in the studio of TVCG (Television of Montenegro) on January 19 at 11:00h and it will be broadcast on January 20 within the morning show of TVCG, which is broadcast from 06:30h until 11:00h.

IX The winner draw shall be attended by the Committee which will supervise the procedure and prepare the corresponding Minutes, on which basis the Report on Winner will be published in the media within the statutory period. The Committee members shall be appointed through a separate Decision.

X The public prize draw will be organised in the studio of TVCG on January 19 at 11:00h and it will be broadcast within the morning show of TVCG on January 20, which is broadcast from 06:30h until 11:00h.

XI. The prizes will be delivered to winners within 7 days following publishing of the Report on Winner in dailies *Pobjeda*, *Vijesti*, *Dan* and *Dnevne Novine*. The prizes shall be presented in the Annex Hall of the EPCG Head Office at 2, Vuka Karadžića St. in Nikšić. EPCG agrees that the winner shall be entitled to transfer the prize to someone else.

It shall not be possible to exchange the goods, i.e. service obtained in the prize contest for cash-value of the won goods, i.e. service, or for another prize.

Employees of EPCG, members of the Board of Directors of EPCG and members of their immediate families, i.e. spouses and supported children, shall not be able to enter the prize contest.

The deadline for prize claim shall be 7 days following publishing of the Report on Winner in dailies *Pobjeda*, *Vijesti*, *Dan* and *Dnevne Novine*.

XII During the period of the prize contest, the Organiser and the entrants shall abide by the set rules of the prize contest, excluding any potential modification thereof.

XIII The rules shall be published and available to all the entrants in dailies *Pobjeda*, *Vijesti*, *Dan* and *Dnevne Novine* before the beginning of the prize contest and upon receipt of approval of the Games of Chance Administration.

XIV The Court in Podgorica shall be competent for any dispute arising between the Organizer and the entrants.

XV As regards the prize fund whereof value exceeds €500 and which remains undistributed after finalisation of the Prize Contest, the Organiser shall sell it at the public auction and pay the amount obtained through the sale to the budget of Montenegro within 90 days following expiration of the prize claim period.

XVI The prize contest under the above rules shall be organised upon acquisition of consent from the relevant institutions.
